Revenues and trained lawyers are both on the rise. Our final count at Rusty is 917! Melissa is recognized for her hard work in making this year's event a huge success.

We have about 2800 dues paying members. Board is reminded that each member has three complimentary memberships to give away to first time members.

Capital Assistance Report

Philip reports on seminars and encourages folks to come to Forensics. The West Texas Capital Defender Office is going strong with 18 cases. His office will again be assisting with Code Books.

CDLP

Mark reports we have trained 2378 lawyers at 20 seminars and have also trained 303 at our capital training.

Publication Report

Cynthia reports that we will be updating our publications after the Session with priority being given to the Code Books (PC & CCP) which our Research Attorney Kathleen is already working on.

Cheat sheets (at least Expunctions and Sex Offender Registration), Traffic Code, State Motions CD will also be updated as needed.

Appellate Manual 2nd edition is being debuted at Rusty and we expect to sell out of the ones we brought with us.

Thanks to Kelly Pace, we will shortly have an update to the Search and Seizure Manual ready to go. Kelly has worked long and hard on this book for no compensation, and has completed the update, but unfortunately it could not be produced in time for Rusty. Updating a book like this one is a huge task and we really appreciate Kelly's hard work on this project.

We will also have for the first time a "non-penal code crimes" manual, which will include excerpts from relevant codes such as Family, Gov't, Health & Safety, etc.

Voice for the Defense

Rick thanks Emmett Harris (who will ascend to the officer chain) for his work on the Voice for the past few years, and compliments Greg Westfall on his work so far.
