We expect in excess of \$200,000 profit from Rusty. We raised \$650 last night at the party for the building fund. Bobby Mims has raised a \$5000 challenge for building fund.

## **CDLP Seminars** Grant Scheiner

Grant reports so far we have had 31 seminars, 270.25 hrs CLE/24.75 ethics Capital CLE 48.75 hrs/3.0 ethics; 279 capital lawyers trained. Total lawyers trained: 2900 Discussion of ways we have cut expenses. We are now venturing into webinars. Bobby Lerma and Mark Snodgrass are 2008-09 co-chairs.

#### **Seminar Committee**

Joseph reports we have about 800 paid attendees. 4161 educated this year, not including Rusty, with \$240,000 net profit projected.

Craig recognizes Gerry and Bill for an outstanding Rusty. It is the best attended Rusty ever with over 800. We even have 46 judges.

#### **Publication Report: Mike Gross**

Mike commends Philip and Cynthia for their work on publications. We want to get a position for a full time staff attorney to help with updates. Salary: \$45-50,000/yr (we will vote in Sept.)

#### Voice: Emmett Harris

Voice is healthy, thanks to Craig Hattersley for the great art and layout. Emmett briefly reports on Ellison and encourages people to write articles.

#### **Criminal Specialization: Craig Jett**

Committee met yesterday and recommended no changes be made to the standards. We will vote on the recommendation in Sept.

#### **Retreat/Board Orientation: Rick reports**

Amicus: Keith reports a brief was filed in support of Jimenez, who got a pro se cert petition granted and is now represented by an east coast law firm.

Corrections: Kelly Pace reports TDCJ is getting new phone contracts. First time parolees are going back to electronic monitoring.

CPS: Pat Metze reports the committee met yesterday and will probably be renamed the "CPS Task

Force." They will work with legislative committee to work on legislation. We will put civil forms on the website and seek to educate and "infiltrate" civil bar.

Death Penalty: John Niland reports there are 175 DP cases on the row. Eight cases so far this year: 6 have gone to death verdicts, 2 for life. The number of cases is shrinking. We have 11 programs planned, most at CAIL. Other capital programs are discussed. The West Texas Capital Defender has hired more lawyers. The CCA has enacted a "48-hr rule" for all last minute motions in DP cases. Craig commends John for all his work, and announces John Wright's "Lifeline Award."

DWI: Larry Boyd thanks Keith and Allen for all their work regarding the pending ALR sunset legislation. New SOAH rules will be our shortly.
